## NSCDA CONGRESSIONAL SEMINAR ESSAY RULES & INFORMATION

The NSCDA is pleased to offer this amazing opportunity to current or rising 10th, 11th, and 12th grade students!

The deadline to submit is 11:59 PM on December 1.

- Essays are judged by their content (focus, accuracy, clarity, and logic), form (grammar, punctuation, and word choice), and individuality (structure, context, persuasion, and style).
- Each student must submit an application form, essay, and list of sources in the MLA or Chicago citation styles.
  - o Note to teachers:
    - ➤ If students are participating as part of a class or school project, please note that all students must submit an individual application form and essay.
    - ➤ Teachers assigning this essay as part of a class or school project should filter the top ten essays to submit to the Congressional Seminar Essay Contest for consideration.
- The essay should be submitted in 12 pt Times New Roman font. The essays must be typed, double-spaced, and, if printed, on one side of the page only. Add the student name and email as a header in the upper right-hand corner of the essay and repeat it on every page.
- Do not attach or insert pictures or add any color text or images to any pages.
- Essays must be 750 words or fewer, excluding the sources cited.
- The title of the essay must be the same as the essay topic for the given year.
- Students submitting physical copies of their application and essay should send three copies of each essay to their designated State Patriotic Service or Essay Chair.
- Email or mail your application and essay to your local/State NSCDA Congressional Essay Chair or Patriotic Service Chair as directed.
